SECTION I

ASSOCIATION NEWS

Twenty-Sixth Annual Conference, San Diego

The German Studies Association will hold its Twenty-Sixth Annual Conference from October 3 through 6 at the Town and Country Resort Hotel, 500 Hotel Circle North, San Diego, California 92108, Telephone 619-7131. Conference Registration and Hotel Reservation Forms are included in this Newsletter, and are also available on the Association's web site at <u>www.g-s-a.org</u> along with other information. Visit the Association web site for all full information.

San Diego is a beautiful city in southern California. Our hotel has swimming pools and recreation facilities as well as excellent meeting room arrangements. It is a conference hotel that is often used for purposes such as ours. This is a very large hotel with both high rise and low rise buildings on a very large area of land, about twenty minutes from San Diego Airport. Because there is so much space between rooms and buildings, GSA will add a few minutes of time between sessions, so that members can more comfortably get from one to another. A map of the hotel will be printed in the Conference Program. Also, because the hotel is so large and is located in a region where there are many such hotels, though not all so large as ours, it is not easy to walk off property for lunch. This is very important! If you try to go off property for lunch, you may not return in time for the next session. Therefore, we have attempted to keep the meal cost for luncheons at a reasonable price, which includes taxes and tip and a beverage. You can purchase lunch from the hotel on site at one of their sit-down areas, but you should keep in mind the number of participants in the GSA Conference (probably about 750), added to the number of regular guests, and you will see that it may be better just to come to the GSA luncheon. Be warned.

Room rates are: Garden Rooms - \$109, East Tower Rooms (Courtyard) \$119, and West Tower Rooms \$129. All rates shown are for either single or double occupancy. You may request any category, and will be assigned to that category as long as rooms are available for that category. After that, you will be assigned to the next available category. Our room block shows 20% in Garden Rooms, 50% in East Tower Rooms, and 30% in West Tower Rooms. Therefore, the least expensive category will very likely be the first to be sold out. Please be certain to select a category on the Hotel Reservation Form. Checkin time is 3pm, and check-out time is noon.

Behind the hotel (a walk through a small park) is the San Diego Trolley, which you can use to go to downtown San Diego for Saturday dinner and shopping. Our own dinner on Friday night will be offered at a very good price, and will feature the Presidential Address, the Awards Ceremony, and a few announcements. If you are staying another night, the hotel will give you our Conference Rate, and you can even take the trolley as far as Mexico. Be sure to take identification so that you may cross the border.

As with all GSA Conferences, you may only book a room at the Conference Hotel through GSA, and this only if you have paid a Conference Registration Fee. Our hotel rates are substantially discounted from the normal rate, and are exclusively available to participants in the GSA Conference. Therefore, we require registration in order to book a room. They are available on a first-come, first-served basis, and our room block will be cancelled if not filled by the deadline the hotel has set. While GSA may be able to obtain you a room after the room block has been filled or after the deadline set by

the hotel, we cannot guarantee this. Consequently, it is important that you reserve a room as soon as you can do so.

If you wish to change the date of a hotel reservation arrival, or seek a different kind of room, this is something that you must take up with the hotel directly. If you wish to cancel a hotel reservation, this is something that you must do with the hotel directly. GSA does not cancel reservations for you. GSA attempts to persuade the hotel to confirm reservations. This is not always possible for a conference of this size. In some cases, GSA can confirm a reservation we have made for you, but the best way to do so is to contact the hotel directly. The hotel does give us print-outs, but these are often late. We attempt to confirm the spelling of your name, to speed your check-in when you arrive.

Conference Registration Cancellation Policy

GSA cancellation policy is fully explained on the web site in the section entitled "Call for Papers. Information. Important – Read FIRST." All Conference Participants must be members of the GSA. A membership form is on the web site. Cancellation and Refund Policy is as follows: withdrawal more than ten days before the Conference begins will allow a refund of all fees less a \$25 service charge. Withdrawal AFTER ten days before the beginning of the Conference (Thursday), will not permit a refund of any registration or meal fees. Meal tickets cannot be transferred by the Association. You must pick up your own meal tickets during the time that the Registration Desk is open. However, you can transfer a meal ticket to someone else if you wish. Last year, someone wanted to go to the Dinner and "did not have the time" to go to the Registration Desk to pick up a ticket. This is not possible. Tickets are required, and can only be distributed at the Registration Desk, not at the meal itself. We have no staff for

that, and I did my best last year when called away from eating my dinner to help the poor lost soul, but we just cannot do that. So, pick up your materials at the desk.

GSA Conference Badges Required

GSA Registration Badges are required for all sessions and meals. No one will be admitted without a badge. Persons without a badge will be asked to leave. Participation in the Conference is a shared-cost and those who try to attend without registering are responsible for higher registration fees for those who do. Admission to the exhibit area requires a badge. In Washington, GSA had a United States Marshal for security purposes. Naturally, only those with badges were allowed.

GSA Pre-Conference Wine Tour

San Diego is located just south of the Wine Country of Temecula Valley. GSA will offer a special bus tour and wine tasting for early arrivers. You can only reserve this in advance. The bus will leave our hotel on Wednesday morning at 9 am, and return in time for the opening of Conference Registration at 3:30pm and the No-Host Cocktail Reception at 6:30pm. It is about an hour and a half drive each way. You will stop at several wineries and have the opportunity to taste their wines, and stop for lunch (lunch not included in the price of the tour). Since the wineries charge for wine tasting, the price of the tour will include one "tasting" at each winery we stop for. In some wineries this includes a variety of wines, in others a smaller selection. You can also order wine to be shipped by the case to your home in another state, providing that your state permits this. The wineries will know. Reservations must be made on the Conference Registration Form and pre-paid. There is no refund for cancelled wine tour reservations, so be certain that you will go. You can check out the scene in advance at <u>www.temeculawines.com</u> on the internet. Do not be surprised if some of the wine personnel speak German.

Conference and Research Trip Travel Discounts

German Studies Association has selected SIGNATURE DESTINATIONS of Phoenix, Arizona, a travel agency affiliated with CARLSON/WAGONS-LITS, as our official travel agency for the 2002 GSA Conference.

GSA has negotiated special airline discounts and car rental discounts for the Conference in San Diego. These are only available through SIGNATURE. The agency has guaranteed GSA that they will offer the best fares available, and the best car rental fees available. You will get personal service at Signature. They are the specialists for flying to our conference location.

In addition, there are special discounts for airline tickets booked more than 60 days in advance of the Conference.

We are trying to serve GSA members in every way possible. SIGNATURE has also agreed to assist GSA members in booking transatlantic tickets for your research travel at low fares, and for all of your travel needs. All of this helps. The more tickets GSA members book through SIGNATURE, the more we can show the individual airlines that GSA has a meaningful traffic flow. We hope to use this to increase discounts available to our members in the future, as well as to bring other benefits to GSA. Up to now, participants have booked their tickets individually in a variety of ways, and it has been impossible to demonstrate that over 750 people fly to our Conference site. This way, we will be able to assist members by offering good fares, and show that we actually do have a heavy traffic flow. Hopefully, we can obtain even better discounts in the future, and more benefits to GSA and its members. Volume discounts help, but the airlines have to see that we fly to our conference site.

Call SIGNATURE at 1-800-486-6884. Call Monday through Friday at business hours in Mountain Standard Time. Or, you can reach an agent directly by e-mail. Two of the several agents available to you are wally@signaturedestinations.com or amy@signaturedestinations.com.

You can have an e-mail copy of your booking, and an e-ticket will ensure that you do not have anything to lose. Just go to the airline ticket counter at your airport when you are ready to leave, and the boarding pass will be issued when you show a picture ID. Don't forget to give the SIGNATURE agent your frequent flyer number.

Flying to/from Britain? Include GSA and We All Save!

Did you know that GSA has a special account at British Airways (Venture Club #7QX001US) under which you can earn BA frequent flyer miles AND, GSA also earns points as well? Whenever you fly BA, give them your frequent flyer number and our number, too. We both earn points. When you book, tell your travel agent to include our Venture Club number along with your frequent flyer number. We both earn points.

Travel Assistance Available for Non-North Americans to GSA Conferences

The GSA Endowment Fund supports a limited amount of travel grants to GSA Conferences for non-North Americans. If you are on the Program, and have been turned down for travel assistance from your government's travel assistance organization or similar entity, GSA may be able to assist you. The Endowment Fund supports and maintains the international character of the GSA Conferences. We are the only major North American scholarly association to do this, and to welcome non-North Americans in our ranks in this manner.

How to apply: Contact the Executive Director of the Association at <u>kleinfeld@asu.edu</u> and request information about GSA Endowment Fund travel assistance. To be eligible, you must have already become a GSA member (membership form is on the web site).

You will need to pay Conference Registration Fees. We all do. GSA is the ultimate non-insider organization. All members of the Executive Committee pay Conference Registration Fees and also pay for their meal tickets, hotel rooms, and travel. The Executive Director pays the Conference Registration Fee along with everyone else. Travel grants are a special feature of GSA, because they have been created out of contributions of GSA members, North American and non-North American residents. If you want to support GSA, contribute to our Endowment Fund.

GSA Endowment Fund News

The GSA Endowment Fund is now at around \$350,000 and comes from the contributions of GSA members and the dues assigned to the Fund. You can contribute to the GSA Endowment Fund. Mark off the special box on your Dues Notice and enclose an amount designated to the Endowment Fund.

Sybil Halpern Milton Memorial Prize

GSA's first named prize is the Sybil Halpern Milton Memorial Prize. It is awarded annually by the Association for the best book on the Third Reich and Holocaust in history, literature, culture, or politics. Contributions towards the endowment of this prize may be sent to the Association Main Office and may be added to your dues payment amount.

GSA Elections in 2002

Not only the German Bundestag and German Chancellor, but also GSA officials will be elected in 2002. A ballot and information are contained in this issue of the Newsletter. This year, we elected a new Vice President, who will succeed to the Presidency, as well as members of the Executive Committee. Be sure to vote. This is your Association.

This is the last time we will have ballots in the Newsletter. The Executive Committee has decided to include them next time with the dues notices.

GSA Nominating Committee for 2003

The Executive Committee has decided to give the Nominating Committee more time to consider candidates for the available positions. This is your Association, and you are all invited to be part of the process. This means sending in your nominations NOW.

In 2003, the terms of Keith Bullivant (University of Florida, Germanistik) and David Barclay (Kalamazoo College, History) will expire. We will fill them with a Germanist and a historian or political scientist. Your suggestions will be heard.

The new Nominating Committee, appointed by the Vice President, who will be President in 2003, Patricia Herminghouse (University of Rochester, Germanistik), with the advice of the Executive Council, consists of Marc Silberman (University of Wisconsin-Madison, Germanistik) as Chair, and the members are Jeff Peck (University of Toronto, Germanistik) and Belinda Davis (Rutgers University, History).

Qualifications for suggested candidates include, of course, membership in the Association and a record of interest and participation. You can e-mail your suggestions to the Chair at <u>mdsilber@facstaff.wisc.edu</u> and should do so as soon as possible.

GSA Web Site Active

If you have not used the GSA web site, you must be one of the very, very few. The web site gets hundreds of "hits" a month, as noted by our counter. Since we are able to update the web site quickly, it can be used for instant information. One use last year was to add information that the deadline for applications for the German Fulbright Seminar Award had been extended. GSA members learned about this with a direct link to Fulbright and the application form.

Don't miss the web site. It will become more and more useful, and you should visit it often.

Next Year's Conference is in New Orleans

Watch the GSA web site for information on the Twenty-Seventh Annual Conference of the German Studies Association, which will be held in New Orleans, Louisiana. As you know, GSA Conferences are held in different regions, and this will be our first in New Orleans.

GSA Affiliation with ASGP

The Association for the Study of German Politics, the organization for political scientists in the United Kingdom who study German politics, has completed a formal affiliation agreement with the German Studies Association. Prof. Charlie Jeffery and Prof. William Paterson, representing the ASGP flew to the United States in February to sign the official document, which had previously been approved by the Executive Committees of both organizations. Recognizing the importance of the GSA Annual Conference in research on German politics worldwide, ASGP has undertaken to provide annually at least two sessions of British scholars and to invite GSA scholars to present at their own annual conference in the United Kingdom. The two sessions might be complete panels, or they might be the equivalent, including North American and European scholars within them.

GSA recognizes that numerous international and domestic scholarly organizations and associations regularly sponsor sessions at our conferences.

Here We Go Again

The USPS has announced a very large price increase for bulk mail and printed matter, along with a three cent increase for domestic postage. GSA members typically receive about 800 pages of printed material each year, including three issues of the journal, two issues of the *Newsletter*, and one copy of the Conference Program. In addition, GSA mails a minimum of one copy of the dues notice, and will probably be enclosing the ballot with the dues notice in the future, unless the Executive Committee decides to keep it in the Winter *Newsletter* to save postage. We have an enormous postage bill.

You can help. How? Please pay your dues promptly, and avoid having us send you a second dues notice. In the meantime, GSA is investigating the possibility of dues payment on line, via the internet. Secretary-Treasurer Fetz (German, Montana) has been sending out a large number of reminder notices via e-mail. This saves some money. A second way to help is to encourage more people to join GSA. If we can break that 2000 member barrier, we can have further economy of scale.

At some future point, we will have to revisit the postage situation. We have now experienced two postage rate increases without an increase in dues payments. We are trying to hold the line. In fact, I have seem an increased traffic in my own e-mail rather than people calling the GSA Main Office. This is helpful. Although we are reluctant to return long distance calls because of the cost, response to e-mail is always possible. This is your Association, and we want to be as open as possible.

Call for Papers: Impact of American Culture

A conference on "Americanization and Anti-Americanism: The Impact of American Culture on Germany After 1945" will be held at the Mershon Center at The Ohio State University from October 18-20, 2002. The conference is expected to contribute to the yet to be written comprehensive history of the transfer of American culture to Europe in the twentieth century. Invited are historians, cultural historians, and anthropologists as well as specialists in media studies, American studies and German Studies. Papers should be broadly construed within the following two areas:

1) The comparative analysis of cultural events in Germany and their origins in the United States, such as the concept of a cultural cold war, the interaction between high and low culture, the youth rebellions of the 1950s and 1960s on both sides of the Atlantic,

theories of modernism and postmodernism or the debate about American cultural hegemony after the demise of communism.

2) The relation between the 'Americanization" of German culture and wider issues, such as elitism vs democratization, westernization, a common European culture, modernization, and globalization.

Funding for the conference has been provided by the Mershon Center for the Study of International Security and Public Policy. This includes traansportation, lodging and meals for all active participants. German academics should apply to the Deutsche Forschungsgemeinschaft. Plans are made to publish the papers.

Between Conformity and Eigen-Sinn: New Approaches to GDR History, Workshop to be held at the German Historical Institute, London, on 11 May 2002

General Aim

Increasingly, scholars of German history in the UK have taken up a concern, with the history of the GDR in recent years. This workshop has been created, to provide a new forum for discussion, to give give participants an, immediate impression of current research trends on the GDR. A second,, equally important feature of the workshop will

be a focus on postgraduate, research on the GDR. Postgraduates and final-year undergraduates, specializing in the GDR in their dissertations will be given priority in, presenting their work, and they will be invited to chair sessions.

Schedule:

Participants are invited to deliver informal papers of 10-15 minutes each, with plenty of time for discussion. The workship starts at 10am, and will, be over by 6pm at the latest. Details of the sessions will be announced at, short notice, once we know who will participate. We would aim for between, 20 and 30 participants.

Travel Bursaries:

We have a substantial travel grant available, and aim to reimburse participants for their travel expenses within the UK. We ask participants to book their train tickets with plenty of time in advance, to keep travel costs to a minimum.

DAAD/AICGS Research Fellowship Program

The American Institute for Contemporary German Studies has announced the final 2002 application round for their research fellowship program, designed to bring scholars and specialists to Washington for stays of 1-4 months. Fellowships carry a monthly stipend of \$4600, plus a monthly research budget of \$250 and economy round trip travel to Washington. Office space at the Institute is provided.

Research Fellows are expected to produce a short publication for dissemination under Institute auspices. Special consideration will be given to proposals that address one or more of the research areas currently being given emphasis by the Institute: transatlantic economic relations, enlargement of the European Union, security issues linking the United States, Germany, and Russia; the evolution of the "New Economy" in the United States and Germany; immigration policy; and cultural or value conflicts between America and Germany/ Europe.



ACLS/DAAD Research Grants

These "Collaborative Research Grants in the Humanities and Social Sciences" support cooperative research projects between German and American scholars. Proposals which deal with East European and Soviet Studies are of particular interest. Grants are means to enable pairs or groups of scholars to work together on any phase of the joint project, from planning to writing and editing.

German and American scholars must apply in partnerships, Germans to the DAAD, Americans to the ACLS. There must be corresponding applications for the same project to each agency, even though it may be that only one side of the partnership wishes to travel in any year. Scholars from the former GDR and younger scholars are strongly encouraged to apply. The awards cover transportation and living expenses. The duration of the scholarship varies, with tenure beginning July 1. Application deadline is September 1. ACLS participation is made possible by grants from the Ford Foundation and the U.S. Department of State. Bernadotte E. Schmitt Grants for Research in European History

These grants are offered to recent Ph.D.s under 35 years of age, and applicants must be American citizens researching on issues within the scope of the Institute's general interest: that is, the social, communal, and intellectual history of German-speaking Jewry. They provide a monthly stipend of approximately Euro 1200, to cover expenses during the time abroad and the entire tenure of the grant must fall within a calendar year. Travel is supported by a lump sum grant of about Euro 450. One six-month and two three-month fellowships are appointed per year. Deadline for applications is November 1. CIES Administered Fulbright Research and Lecturing Grants

There are approximately 50 lecturing/research grants for 3 to 10 months. Award categories are full maintenance, travel only, junior lecturing, and junior research. Preference is given to grant durations of approximately one semester (3 to 5 months) with the exception of academic-year grants to junior lecturers and the Distinguished Chair. These are designed to assist work on a project that will lead to a publication on political, security, and economic matters directly affecting the health of the alliance. Some research time should be spent at NATO headquarters in Brussels, but research may be conducted elsewhere, as well.

DAAD Travel Grants to GSA Conferences

The DAAD has provided GSA with travel grants for our Conferences in 2002, 2003, and 2004 for East European scholars. The grants will fund up to three scholars per year who are presenting papers at the Conference. Applicants must be citizens and residents of a country in eastern Europe, and must speak either German or English. Application must be made after having sent in a proposal for the Conference in the relevant year, either as an individual paper or as part of a session. Applications are made by letter, with a curriculum vitae and a copy of the Conference proposal to the Executive Director of the Association. They will be given rolling consideration, meaning that there is no deadline.

Alexander von Humboldt Research Fellowships

These are awarded to scholars who hold the Ph.D. and are under 40 years of age. The program enables them to carry out research projects in Germany. Applications may be submitted at any time, but should be received at least 5 months prior to the meeting at which they are reviewed. The Review Committee meets in March, June/July, and November. CIAO, which stands for "Columbia International Affairs Online", is a new venture that offers excellent research tools. Access it as www.ciaonet.org and see what it can provide for your research. Much of the material is social science data and papers from conferences, but also information from many data bases. The hitch is that it costs money to use it. Your institution must be a subscriber. The basic cost is \$655 a year and the price varies with the size of the institution. You can try it for thirty days without charge.

TransCoop Program

The Alexander von Humboldt Foundation maintains the TransCoop Program for Transatlantic Research Cooperation. Through this program, the AvH Foundation supports collaborative research involving American, Canadian, and German scholars in the humanities, social sciences, economics, and law.

Successful proposals may receive funding up to ϵ 45,000 (about \$43,000) over a 3-year period. The grant may be used to finance short-term research visits and travel, organize conferences and workshops, purchase materials and equipment, and to cover costs for research assistants and printing.

Applications should be submitted jointly by at least one German and one U.S. or Canadian scholar. Ph.D. is required. Funds provided by the TransCoop Program must be matched with funds from U.S. or Canadian sources. The deadline for applications is October 31. COMPUTERS - BYTES, BITS, AND SOFTWARE

New Computers, New Prices

It is not really possible to update the information on computers as fast as the manufacturers are changing their products and prices, but we will try to bring you some of the latest information as it becomes available.

Windows XP Issues are Fun

Now that Microsoft's Windows XP is out there, and on all PCs that are sold, some interesting quirks have developed. Here are a few of them.

First, the system has a unique licensing feature, designed to help Microsoft get as much out of the product as possible, and to minimize chances that people will pirate it. Thus, any copy you buy to upgrade with is usable by only one computer. One. So, if you have more than one computer in your family, and want to use one upgrade for all of them, Microsoft has news for you. You will have to pay them more money to use it on more than one computer. It is called a family license, is hardly ever sold at a retailer, and is generally only available on their web site. You pay per computer. So, if your family has two or three, plus a couple of laptops, look to spending quite a bundle.

Would you want to upgrade anyway? Well, that depends. Sure, it is better than Me or Windows 2000 or Windows 98, less prone to crash, and all of that. But, upgrading is a touchy thing, and does not always work. You may have to get a local guru to help you.

Even then, it is not always easy. Some magazines report a high failure rate, and people give up. Then, you must understand that it is a NEW system, which is not everywhere backwards compatible. This means that it may not work with your printer driver, and you may have to get a new driver, and that might not be available (check first!), and other program updates may not be available yet. If you have a lot of old software, check it out. You may have to spend more money on updates. Remember, if you have scanners or whatever, everything has to work, so you may wind up upgrading a whole lot of things. The HP Deskwriters are not supported by XP, and a few scanners are not, either. Some older modems are not. This means that you may need new hardware, too. So, do check it out in advance.

New PDA from Sony

Well, by now you all know that I am very high on the little handheld PDAs (personal digital assistants), particularly those running the Palm OS (operating system). I think that these are great for their original uses, to store addresses and telephone numbers, and to keep a calendar and appointment register. I like the Palm variety, which is handy and good, and have preferred the Handspring company's version of them, which uses the Palm OS. I have not liked the Windows OS because it is written for a desktop computer, and causes the handheld user to go through just too many steps to do anything. Palm is simply Palm, and it does well what it is supposed to do. And, it is compatible with both Windows and Mac. If you like the Windows OS in a PDA, that is a personal preference, and it certainly does offer its own features.

That said, Sony has been trying to re-define itself of late. It last a lot of neat products, but does not seem to be able to make money on them.

You have to hand it to the company. They keep on trying. This time, they have come up with a handheld that really upgrades their last effort. The new CLIÉ is sleek and trim. It will fit anywhere without a bulge. It will not bulge in a pocket, nor take up much space in a purse. In shiny silver or royal blue, the Clié runs the latest version of the Palm OS, 4.1, and sports a USB bus (connection port). It has 16mb of memory and a color display that puts all of them to shame. It is 16 bits of color, 320 X 320 backlit, and looks great indoors and surprisingly bright outdoors. Street price in the USA is about \$400, which makes it more than competitive with Palm, and cheaper than the Windows models. Much, much, much thinner, too. On top of that, it accepts the Sony memory stick, a proprietary memory addition system, which you probably will never need.

Look, if you want to use these things to take digital pictures, that's fine. I prefer a digital camera as a second device, but they do do it. You can get the affordable add-on and plug it in. I really cannot see myself accessing the web yet on these small devices, even with the minipriced add-on keyboard, but maybe I am a little old-fashioned. You can do it, though on the higher-end Handsprings and Palms and Windows PDAs, not this one. If you want it to telephone for you, and be your cell phone, you will need a subscription and an add-on, as with all PDAs. Or, you can buy something like the Kyocera and get a phone that runs Palm OS. There is value in that.

The newest handheld is the Treo, by Handspring. You can see it at <u>www.handspring.com</u> and note that it is three units in one. I suppose that is why they use the name Treo. Well, they must have people paid more than professors thinking up names like Treo and Clié. Or else they hire somebody from creative writing.

But, I am hardly ever without my little PDA, and think that it is great

for remembering where I am supposed to be when, and those phone numbers and e-mail addresses that I can never remember if I am away from them too long. Look at the Clie, and you might be captivated. Otherwise, do get yourself a black and white version of the Palm in their lowest priced unit or the Handspring low priced one. They are forever offering sales and lower prices. For less than \$200, you can have one that will surely fit your needs. In a pinch, it takes notes, and reads your handwriting. What else can you ask for?

Apple iMac is like Bauhaus

Not really, but this is a marriage of design and practicality that would even make the designer of the original Coke bottle smile. Every once and a while, Apple strikes out. They did so with that awful cube look. But, having left their cubist period, the Mac designers came up with this magnificent thing. It is a computer that looks like a bubble, with a flat panel display that floats above it and can be positioned in almost any way you would like. Oh, come on, and it is inexpensive, too. Not as cheap as a Gateway, but Mac never strives for that. For a Mac, this is inexpensive, sleek, and takes up so little of your cramped desktop space that you will marvel that you still have a desk left. Why not at least LOOK at it? It runs OS X, of course, and does most of what you need, unless the kids are totally into games and your computer is theirs. It is compatible with that other sleek new product, the one that plays music (will not even be discussed here, nor ever mentioned again). Raised eyebrows in the industry have greeted the iMac, and it is a grand entry into the effort to bring design to the workplace.

EndNote

The latest version of EndNote, 5.0, has appeared. This handy program works with major word processors, and has resident dictionaries for

German and French, as well as other languages. It creates your endnotes, footnotes, and bibliographies. Easy to use, the program speeds up your writing by taking care of one of the most tedious task that often interrupts a scholar's train of thought. The idea of putting this sort of thing in a simple, automated structure, relieving the scholar to write without pausing to look up citations or notes is a really useful tool. The academic price is about \$109.95, though you might be able to find it cheaper. There is also a site license available, so that multiple copies can be sold to reduce the price even further. It works both with PC and Mac, and the files are interchangeable across platforms.
