# LETTER FROM THE PRESIDENT

Dear GSA Members and Friends,

It was energizing to see so many members at our conference in Montréal in October, sharing and vigorously discussing your work, catching up, and making future plans in numbers we haven't seen since before the pandemic. In my two years as vice president/president-elect and now my first as president, I have witnessed the depth of conviction of our membership and the tireless commitment many of you have made to sustaining our multi-generational association through unprecedented challenges. Your devotion to your German Studies research, the deeds and details that make both the GSA and the profession function, and supporting one another as a scholarly community is humbling and inspiring—all the more so given the vast inter- and multi-disciplinary breadth of German Studies and our diverse individual commitments to such a wide range of communities and parallel organizations, regionally within the United States and around the world.

My day-to-day association duties prove to me again and again that the GSA is so much more than our annual conference and the publication of our excellent thrice-yearly journal, *German Studies Review*. In that spirit, I encourage everyone to explore the [“About” section](#) of the GSA website to refresh your overview of the number of committees and activities that take place throughout the year and across physical and virtual spaces, as well as to recognize the scores of members and chairs who comprise and run them. If you are yourself inspired to get more involved or to suggest an initiative you don't see listed, please use this [webform](#) to register your interest or reach out to me directly at [president@thegsa.org](mailto:president@thegsa.org).

Getting involved could mean joining one of our twenty [interdisciplinary networks](#), our [journal and book series editorial boards](#), or dozen-plus [standing and ad hoc committees](#), including the [program committee](#) that reviews submissions for conference presentations or sessions. Participation could also mean attending an online town hall, the annual in-person member meeting on the Thursday evening of the conference, or sending an email to an officer or board member to ask a question or share an idea. The creativity and concerns that come through those channels not only foster discussion, but they help shape the agenda for [executive council](#) and [board](#) meetings.

Highlights of recent association business can be found in the abbreviated board meeting minutes in the following pages. Plans for the coming year include: a thorough-going review of association's bylaws with an eye to an update to be approved by the general membership within two years; the expansion of our slate of awards to include a prize for exceptional mentoring; the establishment of a disability and accessibility task force; piloting a program for collaborative

regional gatherings co-sponsored by the GSA and other allied entities; hosting an online event featuring the winners of the 2023 book, article, and essay prizes; providing online office hours with the president to discuss the GSA mission and governance structures; and transitioning the conference's undergraduate research panel from its pilot phase to a regular place on the program. None of this would come to life without the talent and resourcefulness of our part-time staff of highly regarded German Studies scholars, who also want to hear from and work with more of you!

As members, you can help shape the future of German Studies and GSA by participating in the upcoming elections in spring 2024. Each year, the GSA's nominating committee sends a slate of nominees to the secretary who distributes an electronic ballot via the newsletter and an announcement on the website. A simple majority of all votes is required for election. There will be positions open for: a graduate student representative to the board (for a term of two years, regardless of a change in status during the term); two at-large board members (one in the area of literature and cultural studies and one in history and social sciences, each broadly defined, for a term of three years); as well as a candidate for vice-president/president elect (this year from the area of literature and cultural studies broadly defined, who will serve as vice president for two years under now president-elect Damani Partridge and ascend to the presidency in 2027). If you are interested in nominating yourself or a colleague to be considered by the nominating committee for inclusion on the ballot, please reach out to the committee chair by the end of this calendar year. Nominations by petition are also possible. Per the bylaws, "Committee members should nominate scholars who are esteemed in their disciplines and have distinguished themselves in the past by their contributions to, and active participation in the Association. Normally, candidates nominated for Vice President will have served previously on the Board. ... Additional nominations may be made by members of the Association with nominating petitions signed by ten percent of the membership for each nominating petition and office. No member may sign more than one nominating petition for each office. The Nominating Committee shall include on the ballot individuals nominated by petition." And please remember to vote this spring!

We plan for the same spring newsletter where you will find the annual election ballot to also include a member survey. The survey is a first step in strategic planning, timed to coincide with the GSA's upcoming 50th anniversary in 2026. It will be designed by committee to seek inclusive input on an association mission statement and the main foci or pillars for the upcoming strategic plan. Specific sub-committees will be created around each pillar. Together, the committees will help set a comprehensive vision for merging our existing strengths with new signature initiatives and twenty-first century priorities. Reach out to me if you already know you want to be a part of the process; keep a lookout for newsletter and other announcements related to strategic planning in GSA emails and social media posts; and be sure to fill out the survey!

Lastly, for many of you, supporting the GSA might mean contributing to one of our dedicated funds or to the general support pool. Donations go to recognizing a given year's best books, articles, and essays; providing wider economic and structural access to the organization's activities; preserving and disseminating the history of the organization; and expanding those awards and activities into new realms under the board's leadership. Recognizing that overall engagement and participation are as valuable as the bottom line, our goal this year is to increase not only the amount we raise, but also the proportion of our membership who give. I am gratified that 2023 brought so many new members to the GSA. The area where we grew the most in terms of conference registration and attendance was in graduate student and contingent faculty numbers. That underscores how crucial it is that those of us in more secure positions and with access to resources carry our share while intentionally creating more room for the equal participation of those who historically have been harmed, excluded, marginalized, silenced, or discouraged in or around professional and learned societies. I look forward to continuing to find that kind of support in one another in the year ahead!

We are excited to issue this call for the next Emerging Scholars Workshop (ESW) to be hosted at the 48th German Studies Association Conference in Atlanta, Georgia, on September 26–29, 2024. This workshop is only open to graduate students.

The ESW will run parallel to the established seminars, regular conference sessions, and roundtables. It will convene Friday through Sunday, 8am–10am. Over the past decade or so, graduate programs across the country have contracted. Now, fewer graduate students encounter fewer regular graduate courses, which have also become more general in content to meet satisfactory enrollment. As a result, much of the specialized, yet crucial field training has moved into one-on-one tutorials and directed readings. The ESW gives an up-and-coming cohort of scholars access to leading faculty in their fields. It increases the advice and mentoring they receive and cultivates a sustained professional conversation. The goal is to enable the next generation of Germanists to produce their best possible work, be competitive across fields, and contribute to the vitality, relevance, and productivity of our fields at large.

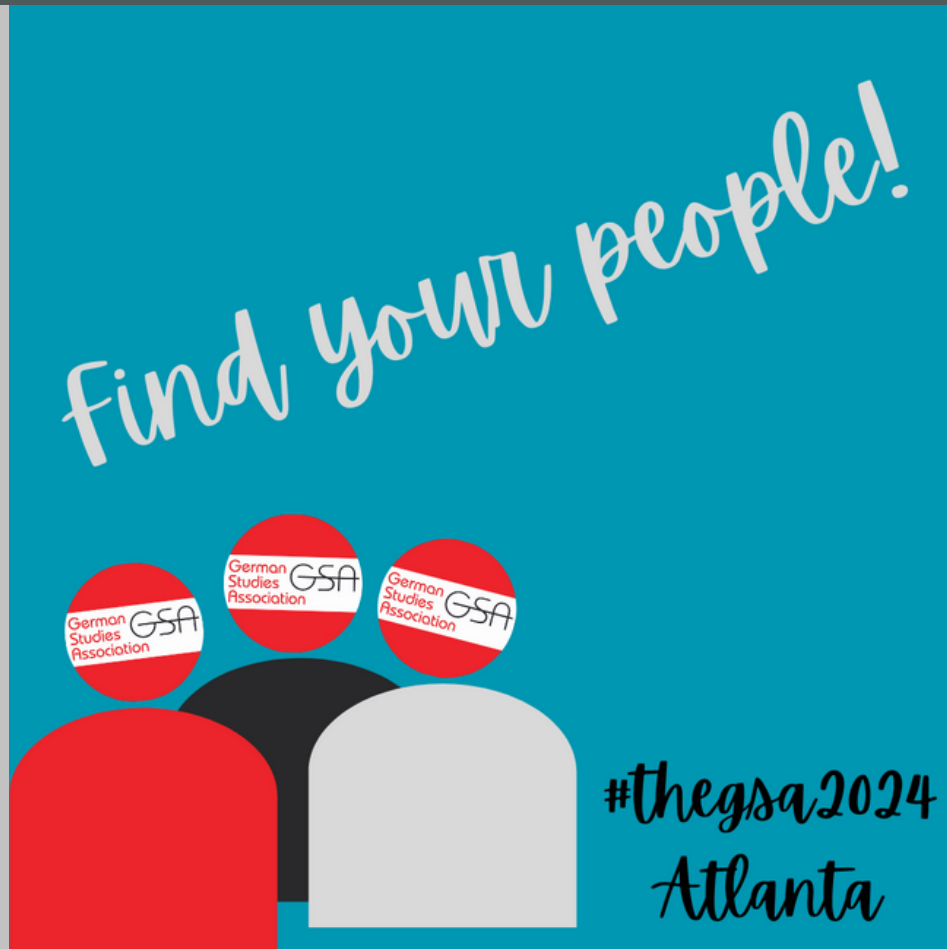

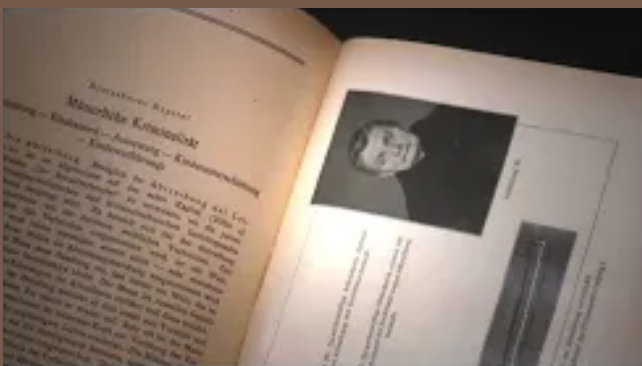

# GSA 2023 FOOD FOR THOUGHT VIDEOS

# ANIL BHATTI IN MEMORIAM

Anil Bhatti (1944-2023), Professor Emeritus at the Centre of German Studies, School of Language, Literature and Culture Studies at the Jawaharlal Nehru University New Delhi, passed away on October 11, 2023 in Delhi. He is remembered and missed by colleagues in India, Germany, and around the world as an institution builder, a brilliant and prolific scholar, and above all a generous colleague, teacher, and mentor to many generations of scholars within and outside of India.

Along with luminary historians such as Romilla Thapar, economists such as Amartya Sen and literary scholars such as Meenakshi Mukherjee, Anil Bhatti belonged to the group of intellectuals born at the cusp of Indian independence from two hundred years of British colonial rule. Combining their cosmopolitan spirit with sincere investment in a newly independent nation, Bhatti and his contemporaries turned post-colonial Indian universities into major centers of disciplinary training, but also discipline-transgressing thought and critique. Their contributions to fortify freedom of speech and responsible social action in the public spheres can never be underestimated.

Bhatti studied Germanistik, Political Science, and Philosophy at the Ludwig Maximilian University in Munich and wrote a dissertation on “Clemens Brentano und die Barocktradition” (published 1972). In 1971, he returned to India to work for the newly established Jawaharlal Nehru University, and became the founding pillar of the Center for German Studies (CGS), making modern German literary and cultural studies an important critical field in post-Independence India, and the CGS the leading center for international cultural exchange, dialogue and debate. After being promoted to the rank of Professor in 1983, Bhatti served as chair of CGS many times, and through his leadership and expertise became a much sought-after expert who served national-level committees dedicated to advancing Foreign Language Studies in India.

Bhatti’s publications are stunning on many counts: in their thematic breadth and intellectual depth. His early publications in the journal *Social Scientist* include topics such as “Logic, Dialectics, and Theory of Knowledge,” “Realism in

Marxism,” as well as critical commentaries on books on India published in the German-speaking world. By the mid-1980s, a decade and a half into his career, Bhatti’s publications demonstrated a real effort in understanding the place of India in German thought and literature, but as a case study to understanding the very place of decolonized Asia vis-à-vis a post-colonial Europe. His volume, *Utopie, Projektion, Gegenbild: Indien in Deutschland* (1987) is remarkable for foreshadowing the identification of vantage points that would be celebrated as “postcolonial theory” in Anglo-American Academy in the 1990s.

But he was equally invested in thinking about Lukács with Hungarian scholars in Delhi (*The Lukács Papers*, 1985), writing on Heidegger, and exploring hitherto underrepresented areas of Indian history in connection with Europe. His edited volume *Jewish Exile in India 1933-1945* (1999) remains one of the foremost documents on both Indian and (German) Jewish histories. The contributors to this volume—from Germany and India—perform multi-faced examinations of a cataclysmic event in worldwide migration, which eventually led to major contributions of Jewish intellectuals, filmmakers, and composers to the cultural landscape of India. Remarkable about Bhatti’s contribution to the volume is his deep awareness of violence that marked the Second World War, the Holocaust, and the years surrounding India and Pakistan’s freedom through partition. This stream of Bhatti’s interventions would find extension throughout his later years, even after his “formal” retirement from JNU in 2009.

Bhatti’s service and his impact extended far beyond the classroom or his publications. From 1996 to 2001, he presided over the Institute for the Research and Promotion of Austrian and International Literary Processes in Vienna. He was the President of the Goethe Society of India from 1998 to 2012, and he received many prestigious awards, including the Jacob-und Wilhelm-Grimm-Prize of the Deutscher Akademischer Austauschdienst (DAAD) in 2001, the Verdienstkreuz 1. Klasse des Verdienstordens der Bundesrepublik Deutschland in 2005, and the Österreichisches Ehrenkreuz für Wissenschaft und Kunst 1. Klasse in 2011. He was a Fellow at the Kulturwissenschaftliches Kolleg of the University of Konstanz from 2010 to 2011. In 2011, he received the highest award

for international scholars, the Humboldt-Forschungspreis from the Alexander von Humboldt Foundation. He held visiting professorships in Kassel in 1991, in Graz in 2001 and 2009, in Vienna in 2002, and in Tübingen in 2006 and 2010. In 2021 Bhatti was conferred the honorary doctorate (Honoris Causa) by the Faculty of Philosophy of the University of Zurich.

Those who know him well also appreciate Bhatti's immense knowledge of modernist paintings and his contributions to discussions of modern Indian art. Through his lifelong friendship with the celebrated Indian painter and installation artist Vivan Sundaram (1943-2023), Bhatti was involved with the *Journal of Arts and Ideas*, edited by Sundaram and his wife. Bhatti was one of the main speakers when the Haus der Kunst in Munich exhibited *Umbrüche* (2018), the last and most comprehensive retrospective of Sundaram's work.

Bhatti's last Humboldt Fellowship was in Tübingen in 2022. True to his collaborative spirit, his last published volume was a co-edited collection *Ähnlichkeit: Ein kulturtheoretisches Paradigma* (2021) with Dorothea Kimmich, his host and collaborator. The volume makes a compelling case for reviving multiple rediscoveries of similarities among cultures, nations, and peoples, instead of a reductionist celebration, almost fetishization of difference. Here as well, without falling into vacuous phrasing or empty signs, Bhatti and Kimmich identify, and call upon the readers to engage with, the complexities of the term "similarity," beyond simply affinities or overlaps. The text is a befitting testimony to Bhatti, his generosity, his desire to stay curious and assist others with their curiosity beyond the narrowness of identity politics founded solely upon difference.

As a direct beneficiary of Bhatti's legacy, his enabling mentorship and support, decades after I had left JNU, I thank him today, along with many others, for leaving a rich legacy of thought, critique, and collaboration.

# 2023 ARCHIVES REPORT

Die Unterlagen zur NS-Zeit gehören zu den besonders häufig genutzten Beständen des Bundesarchivs. Zuletzt gingen jährlich etwa 56.000 Anträge dazu ein, darunter rund 42.000 Anfragen personenbezogen, zum Beispiel zur Aufklärung der Familiengeschichte.

Das Bundesarchiv intensiviert daher die Digitalisierung zentraler Bestände aus der NS-Zeit. Einer der Schwerpunkte liegt auf Akten militärischer Herkunft, die im Anschluss größtenteils online zugänglich sein sollen. Möglich wird das durch zusätzliche Mittel des Deutschen Bundestages in Höhe von 13,5 Millionen Euro. Bundesarchiv-Präsident Michael Hollmann sagte: „Die Unterstützung des Deutschen Bundestages gibt uns einen weiteren Digitalisierungsschub. Indem wir wichtige Unterlagen aus der NS-Zeit schneller digital nutzbar machen, tragen wir zur immer wieder dringend notwendigen Aufklärung über diese finstersten Jahre der deutschen Geschichte bei. Zugleich erleichtern wir den Zugang für die Forschung und helfen Angehörigen, das Schicksal ihrer Familien besser aufzuklären.“

Zu den für die Digitalisierung vorgesehenen Beständen gehören zum Beispiel die der Wehrkreiskommandos, die Divisionsbestände der Wehrmacht sowie Luftbilder. Auch Lagekarten des Zweiten Weltkriegs sind darunter, etwa des Generalstabs des Heeres, die unter anderem der Nutzung im Führerhauptquartier dienten. Ihre Verarbeitung ist besonders anspruchsvoll: Es handelt sich um über 10.000 Karten mit Formaten bis zu 2 mal 3 Meter und Einzeichnungen von großer Detailtiefe.

## **Introduction**

- Meeting agenda unanimously approved. May 2023 Board meeting minutes unanimously approved.
- Welcome, introductions.

## **Report from President Sara Hall**

- Responsibilities and role of Board; considering ideas from ACLS leadership training; plan to use spring virtual Board meeting as retreat to consider function and mission of GSA.
- Better formal process for committee reporting needed.
- Update on summer experience at ACLS Intention Foundry, which aimed to get input to leadership from graduate students and young scholars. The meeting generated plans to work on challenging structures of privilege in academia (“hidden curriculum”) and to make international students more visible at and give them greater access to the GSA.
- On-going search for editor of Spektrum to replace David Luebke as Series Editor; hope to have new editor by early spring.
- Member survey in Spring Newsletter to ask for input on mission statement input and pillars of focus, and then establish committees around each pillar.

## **Report from Operations Director Jen Jenkins**

- About 1500 participants for 2023 (vs about 850 at 2022 meeting!).
- Improved processes for identifying overcommitted scholars and for helping people “take a grad to lunch/dinner” donations.
- Next time need to invite guest conference speakers earlier.
- 2023 Conference data as of 25 September 2023
- 24 Seminars (including Emerging Scholars Workshop), 316 participants (cf. 2022: 14 seminars, 163 participants)
- 41 Roundtables, 226 participants (cf. 2022: 26 roundtables, 151 participants)
- 192 Pre-formed Panels, 980 total participants, 617 presenters (cf. 2022: 110 panels, 570 total participants, 357 presenters)
- 1 Undergraduate Research panels, 5 presenters (cf. 2022: 2 panels, 7 presenters)

## **Report from Secretary David Imhoof**

- Elections in April-May 2023 for three positions to the Board: Germanistik, 20th-21st century History/Social Sciences, and Early modern-19th century History/Social Sciences. Welcome to Faye Stewart, Denise Phillips, Paul Lerner; all three terms begin in 2024 and run for three years.
- Planned member survey for March 2024.
- Bylaws Revision: From 2021 to 2023 the need to revise grew from minor additions/changes to the decision to overhaul the Bylaws completely. Goal is to make bylaws simpler, like many other organizations do, with a document on practices that could be amended/changed much more easily. Timetable: Ad-hoc committee work in first half of 2024, revision to Board by fall 2024 and to members fall 2025 for approval.

## **Work on Mission/Vision Statement, led by Hall**

- Motion to send Statement to membership by March – *passed unanimously*.

## **Report from Executive Director Margaret Menninger**

- Two important issues facing the GSA: 1) growing requests from members for services from GSA, especially from contingent and precariously employed scholars, and 2) declining revenue. For example, we gave out ca \$95,000 in grants (10% of endowment) but only got about \$5,000 in donations. We may have to make some decisions about conference amenities vs. revenue, including raising membership and registration fees. GSA membership and conference registration is lower than at most other similar organizations.
- The gap between precarious and established members has grown: half of our membership are at the lowest tier of membership.

## **Report from Treasurer Tom Haakenson**

- Overall financially healthy.
- About 20% of operating budget (about \$400,000 to 450,000) goes to grants, fellowships, prizes.
- We have now disaggregated one large TIAA fund into individual funds for specific awards, prizes, as well as a general endowment fund. We retain an account at Wells Fargo for cash payments.
- Because of significant increase in memberships at lower levels we may need to increase fees, especially for higher tiers of membership.
- The Conference Community Fund was set up to help faculty members who lost positions/funding, but this fund is now increasingly going to grad students who need to present at the GSA but have no institutional funding (including some at R1s who *should* have funding). Received about \$5000 in donations this year, and we also use 4% draw down from endowment. All but one person who applied received money.

- Finance Committee suggests we develop overall plan for endowment draw.
- Finance Committee will consider impact of raising membership fees.
- Discussion of how to pressure graduate programs to provide funding for students to attend conferences, instead of GSA paying.
- Discussion about whether undergraduate students might also apply for assistance from the Conference Community Fund.
- Motion to approve the 2024 budget – unanimously approved.

## **Motion brought before the membership**

- Motion that the GSA create a mentoring award – all in favor with one abstention; passes. Plan to bring this motion to the entire membership today in the Membership Meeting and, if passed, authorize the president to create a committee to administer the award. (Note: membership endorsed this motion.)

2) enhanced disability and accessibility at the Montreal hotel; 3) setting up a graduate student reception, which would be especially helpful for those not coming from schools with large cohorts; and 4) seeking new members to replace those rotating off the ITSJ Committee this year.

## **Mission and Vision Statement draft**

Task force reported good engagement and input from members but wondered how to expand input, especially from scholars from less-represented disciplines. There was discussion about need for the Statement to express a desire to expand the GSA's membership and reach beyond North America and Europe, bearing in mind that the GSA is not the only German Studies group in the world and that we should seek to work with other groups. The next strategic planning steps would be to create "strategic pillars" with attendant committees, ultimately aiming to complete strategic planning by 2026.

## **Treasurer Tom Haakenson's report on finances and fundraising**

We filed 2021 taxes in November 2022 but are trying to move to a May filing in the future. We've had limited success in fundraising, but we're still considering new ideas and especially how the Board can help.
