#### **GSA Annual Board Meeting Action Items Summary**


49th GSA Annual Conference, Crystal Gateway Marriott, Arlington, VA Thursday, September 25, 2025

**Present**: Vance Byrd, Astrid M. Eckert (new, non-voting member), Alicia Ellis, Tiffany Florvil, Katharina Gerstenberger (ex officio), Sara Hall, Todd Herzog, David Imhoof, Lorna McCarron, David Meola (ex officio), Margaret Menninger (ex officio), Heather Morrison, Jonathan Olson, Damani Partridge, Denise Phillips, Christine Rinne, Qinna Shen (new, non-voting member), Faye Stewart, Kira Thurman (new, non-voting member).

- 1. The Board approved the Minutes from the September 2024 Board meeting.
- 2. The Board approved membership rate increases to improve to help cover the GSA's budgetary deficit:
  - a. Increase of \$25 for members earning less than \$50,000 per year
  - b. Increase of \$40 for members earning between \$50,000 and \$90,000
  - c. Increase of \$60 for members earning \$90,000 and above
- 3. The Board approved the proposal to reappoint Menninger as Executive Director.
- 4. The Board voted to recommend that the Accessibility Task Force become a standing committee, a move that will be considered as part of an ongoing overhaul of the bylaws.
- 5. The Board approved conference registration increases, also to help the deficit.





# GSA/DAAD Article Prize Winner

Später: Objectless Eschatology and Radical Hope in the Poetry of Paul Celan

Asif Rahamim

ABSTRACT

In this article, I examine Paul Celan's career-long preoccupation with the notion of a new beginning and the eschatological possibility of bringing about a hoped-for better future through the artistic act. Drawing on three major reference points in Celan's conceptualization of this struggle—Heidesgerian eschatological thought, Jewish messianism, and the utopian tendencies of the early 20th century European avant-garde—I suggest another theoretical framework through which to understand Celan's divergence from these approaches: Jonathan Lear's theory of "radical hope," Although not a literary concept, I argue that Lear's "radical hope" offers a unique vantage point from which to consider what I call Celan's "object-less hope," shedding new light on its peculiarities and on the poetic techniques with which it is made manifest.

### IN MEMORIAM: JAMIE MELTON (1952-2025)

Some losses are so unexpected that the mind refuses to believe. James "Jamie" Van Horn Melton passed away suddenly and unexpectedly at his Atlanta home on June 28, 2025. He was a pillar of the History Department of Emory University and of the Emory community more broadly. He was a longtime GSA member and served as president of the Central European History Society. Jamie was also a crossroads of cultures. Born and raised in the South, he absorbed Viennese charm by osmosis and combined it with a Salzburg accent through marriage.

Jamie grew up with his parents and two brothers in Chatham, Virginia. His education took him from Vanderbilt University (BA, 1974) to the University of Chicago (PhD, 1982), where he worked with Leonard Krieger. During his doctoral studies, a Fulbright scholarship allowed him to conduct dissertation research in Vienna. After completing the PhD, he spent two years as an assistant professor at the University of Arkansas at Little Rock, three years as an assistant professor at Florida International University, and in 1987 he joined the faculty at Emory. Jamie touched the lives of many on Emory campus as a distinguished scholar, generous mentor, inspiring teacher, engaging and supportive colleague, and kind friend. He unfailingly answered every service call that reached him and ended up chairing no fewer than three different Emory departments: History, German Studies, and—wait for it! —Spanish and Portuguese. Without missing a beat, this Germanist turned around and enrolled in Spanish classes.

### IN MEMORIAM: JAMIE MELTON (1952-2025), CONT.

We are fortunate to inherit Jamie's scholarship. He left a profound mark as a historian of early modern Europe, Germany, the Enlightenment, and the Atlantic World. He published three single-authored books with Cambridge University Press. His dissertation work turned into Absolutism and the Eighteenth-Century Origins of Compulsory Schooling in Prussia and Austria (1988), a book that won the 1990 Hans Rosenberg Prize awarded by the Central European History Society. His second book made good on the promise of the first: The Rise of the Public in Enlightenment Europe (2001) has been translated into Spanish and Turkish and will posthumously appear in Russian. In his last book, Jamie combined the far and the near: the history of the Atlantic world, Austrian history, and the history of our home state, Georgia. Religion, Community, and Slavery on the Southern Colonial Frontier (2015) tells the history of Ebenezer, a frontier settlement in colonial Georgia founded by a Protestant mountain community fleeing religious persecution in its native Salzburg. The book was awarded the Center for Austrian Studies Book Prize in 2016.

His contributions, however, also lie in the numerous edited collections and peer-reviewed articles that he authored. Sometimes Jamie was hiding a bombshell where you wouldn't look for it, like his seminal chapter on the historian Otto Brunner in a collection he co-edited with Hartmut Lehmann. Published in 1994, the piece explored the roots of German social and structural history and found them where they lay: in folk history (*Volksgeschichte*), on the political far right, in the conceptual shift from *Staat to Volk*. As German historians grappled with the role of the profession during National Socialism over the later course of the 1990s, Jamie had already quietly opened that path.

### IN MEMORIAM: JAMIE MELTON (1952-2025), CONT.

Jamie retired from teaching at Emory in 2023, but he remained adamant about his research. He was still working on a new book, entitled *The Imperial Lives of Lorenzo Da Ponte* that will forever be missing in the Central European historiography. The project had grown out of Jamie's longstanding interest in Mozart and his cultural world that also infused his teaching, for instance, in the seminar on "Mozart's World, Mozart's Women" that he used to offer. The life of Da Ponte (1749-1838), Mozart's librettist and collaborator, unfolded across the imperial metropoles of Venice, Vienna, London, and New York. In following Da Ponte's cultural odyssey from the Old World to the New, Jamie hoped to explore how this man on the move—and on the make—made sense of his life and of his world through a constant process of cultural adaptation and reinvention.

Most importantly, Jamie was a man of good will, of integrity, courage, and compassion, who sought to do right by those who were in his life or crossed his path. Jamie was a loving husband and father, a devoted son and brother, and a committed friend. He was also a generous colleague, mentor, and teacher, and a respected leader who had the courage to stand up for his values and defend the vulnerable. Though erudite and accomplished, Jamie completely lacked pretentiousness. His wit, charm, and adventurous spirit brought smiles and joy to those who knew him. He is deeply missed.
